1. **Amalgamated classes and Class awards:** Classes G and H are amalgamated. In classes A, F, and the amalgamated class G/H there will only be a 1st in class award. In classes B and E there will only be 1st and 2nd in class awards.
2. **Amendment to Road Book:** On page 5, amend the access code for the TCS/NERS document upload system from 5360 to 5369. The QR code **is** correct.
3. **Tyre Declaration Form:** The tyre declaration form will be issued at MTC1 and is to be returned with your damage declaration (at MTC2 for finishers, and to Rally Office for retirements).
4. **Driving Behaviour:** Driving Standards Observers/Judges of Fact have been appointed to observe driving standards on the road sections of the event. They will report to the Clerk of the Course any driving at excessive speed, or erratically, or in a manner likely to alarm spectators (this includes any “tyre-warming”).
